BJMP Addresses Mental Health Concerns Among PDLs



Global statistics reveal significant mental health challenges within incarcerated populations. Among a worldwide group of 33,588 prisoners, records indicate that 1 in 10 experience major depression, and nearly 4 percent face psychosis. A study further detailed that the pooled prevalence of major depression was 10.2 percent in male prisoners and 14.1 percent in female prisoners. Similarly, the pooled prevalence of psychosis was 3.6 percent in male prisoners and 3.9 percent in female prisoners. In the Philippines, mental health challenges among Persons De-

prived of Liberty (PDLs) are often exacerbated by factors such as overcrowding, inadequate resources, and limited access to care. Beyond the inherent stressors of the Philippine jail ecology, the psychological struggles of PDLs frequently originate from broken homes and deep-rooted trauma. In a proactive response, the Bureau of Jail Management and Penology (BJMP) and DIGNITY are illuminating a path toward mental wellness in prisons through their collaborative initiative, "Well-being behind Bars." This partnership has produced a prachealth needs of the Philippine jail system. Journalist CHANDO PAREDES MORALLOS writes 30

It is with profound sadness that we announce the passing of Chando Paredes Morallos, a distinguished author and public relations professional, at the age

Chando was a former journalist with the Philippine Daily Inquirer and served as Desk Editor of the Manila Bulletin. A lifetime member of the National Press Club of the Philippines (NPC), he was also known for his vibrant presence as one of the dynamic emcees of the NPC's "Celeb-

rity Night" held every Friday. Chando's literary contributions include a notable collection of coffee table books: Treasures of the National Library; From Galleons to Computers - A History of the Philippine Postal Corporation; Guardians of our Borders - A Centennial History of the Bureau of Customs; From the Ranks - A Biography of Titus B. Villanueva, Bureau of Customs Centennial Commissioner; Humane Jails and Sentinels - 16 Years of the Bureau of Jail Management and Penology; and The MMDA Mission of Compassion for the Victims of Super Typhoon Yolanda.

Affectionately known as the "Trini Lopez of the Philippines," Chando had a passion for singing, often sharing his talent with celebrity guests at NPC Celebrity Night and enjoying videoke with friends, particularly his fellow journalists and politicians.

Renowned for his wit and repartee, which earned him the moniker "Chandoism," he was deeply loved by his peers and his fellow "Waray" people from Gamay. Above all, he was a devoted husband, father, and grandfather.

Born on March 28, 1945, in the town of Gamay, Chando Paredes Morallos passed away on May 13, 2025.

He is survived by his beloved wife, Terry, his children, Aldrin and wife Ethel, Charmaine, Robert and Galilee, and his cherished grandchild, Frank Lloyd, Ashley Rein and Luke Simone.


