

Kalingang Bumbero Marks First Anniversary, Aids Over 300 Individuals in Mental Health Crisis

QUEZON CITY - On May 27, 2025, the Kalingang Bumbero project celebrated its first anniversary at the Linsangan Hall of the Bureau of Fire Protection (BFP) National Headquarters. A collaboration between the BFP National Capital Region (BFP-NCR) command and the National Center for Mental Health (NCMH), the initiative has provided crucial mental health support to over 300 individuals since its launch a year

The project, spearheaded by then BFP-NCR Director Chief Superintendent Nahum B. Tarroza, established a 24/7 hotline 0962-458-4237, with "237" representing "BFP" to offer immediate assistance to those experiencing mental health crises. To date, the program has aided more than 300 callers seeking help, including 32 suicidal cases, through its team of professional and highly trained psychometricians and psychologists. The Kalingang Bum-





bero program is operated by BFP personnel under the leadership of Senior Inspector Joan M. San Juan, Chief of the BFP-NCR Regional Mental Health Unit. It began with 114 call operators and counselors dedicated to addressing emotional challenges through the mental

health crisis hotline. Seeing the sig-nificant and timely support the program offers, BFP-NCR Officer-in-Charge Director Senior Superintendent Jerome T. Reano has decided to continue the Kalingang Bumbero project, acknowledging the critical need for mental health support amidst rising cases.

Impact and **Personal Stories**

BFP Chief Directorial Staff Chief Superintendent Manuel M. Manuel, speaking on behalf of Chief BFP Director Jesus P. Fernandez, underscored the project's significance, particularly during these challenging times for many Filipinos. He shared his personal battle with depression stemming from chronic back pain that almost led to paralysis, requiring surgery and extensive physical ther-

Magalona, designated as the program's "Mental Health Ambassadress," lauded the project's continued relevance and timeliness. She commended the compassionate and professional hotline counselors for their readiness to listen, assist, and guide individuals struggling with depression. Magalona also emphasized the profound importance of a strong relationship with God as a foundation for overcoming anxiety and depression.

In 2023 alone, the BFP-NCR Special Rescue Force successfully rescued 31 individuals from suicide attempts, highlighting the urgent need for such interven-

Addressing a Silent Epidemic

The rising concern of mental health is being recognized as a silent, emerging epidemic that demands serious governmental attention. Government records indicate that an estimated 12.5 million Filipinos suffer from various mental health conditions, with depression and anxiety being predominant.

The Kalingang Bumbero project aligns with the expanded mandate of the BFP under RA 11589 (BFP Modernization Act). This act broadened the Fire Bureau's public safety services beyond traditional firefighting to include disaster response, hazardous materials handling, and specialized training for firefighters, among other areas, effectively mandating the agency to develop a comprehensive fire safety and

protection program that now includes mental health support.

The anniversary event was also attended by Dr. Sharlene Mae P. Ongoco, Director of the NCMH Crisis Hotline, and Antonio Zafra, who represented 911 National Emergency Hotline Director Francis Fajardo.





After nearly four decades in the business. Marita looks back with a sense of fulfillment. Opening another branch is undoubtedly an achievement, but the most meaningful success for her was sending her two children to college.

'Take the risk, even if it's not your planned path. One day, you'll thank yourself for having the courage to start," she concluded, leaving an encouraging message to those held back by fear and doubt.
