

One of the highlights of the donation drive was the turnover at Salinas Elementary School, which coincided with Bacoor City's official opening of Brigada Eskwela 2025.





LAS PIÑAS CITY – With a formidable arsenal of eleven fire trucks, two ambulances, and 155 dedicated firefighter-rescuers, the Bureau of Fire Protection (BFP) Las Piñas City Fire Sta-

tion (LPCFS) stands prepared to tackle any emergency. Their primary mission: to save lives and protect property for the city's population of over 600,000 residents, particularly during fire incidents.

While the LPCFS op-

erates with fewer personnel than the ideal ratio of one firefighter per 2,000 people and one fire truck per 28,000 residents, the local government unit significantly augments their capabilities. This sup-

As the BFP moves towards full modernization, each fire station

within the command is now equipped with self-contained breathing apparatus (SCBA) for every responding firefighter, supported by

two refilling machines. The LPCFS is committed to continuous readiness, regularly implementing non-stop fire scenario drills in both business establishments and communities A recent full-scale drill at a local hospital, for instance, trained all personnel in the safest and most efficient practices for evacuating patients and other occupants during a fire or earth-quake. This initiative

aims to minimize potential harm, maintain critical healthcare services. identify weaknesses in evacuation procedures, test fire safety systems, and promote staff preparedness.

City Fire Director Superintendent Josephus F. Alburo, known for introducing innovative best practices, believes that public servants, especially those involved in public safety, must embody goodness, reliability, and decency. Inspired by Alburo's vision, the collective efforts of Las Piñas firefighters have led to Project FLAMES (Fire and Life Safety Managing Emergencies). This school-type simulator center, staffed by LPCFS Emergency Medical Service firefighters, teaches schoolchildren essential fire safety practices. Children experience simulated calamities

BFP Las Piñas, Always Ready,,, from p.3 like fires, earthquakes, and floods, learning what to do in such situations. The program also instills self-discipline, cleanliness, and the principles of responsible citizenship.

Marking another novel initiative, Alburo has overseen the installation of a high-resolution 360-degree camera. This system provides an unparalleled, comprehensive view of the city and neighboring areas, revolutionizing fire monitoring efforts.

Recognizing critical importance of prompt reporting, Alburo urges the public to immediately contact the nearest fire station or the national emergency hotline 911 as soon as a fire starts, rather than engaging in activities like livestreaming on social media platforms. (Benjie J. Murillo)

Influencer-Vlogger Praises Say Duo for Giving Manileños a Choice in Recent **Elections**


Michael Say's commitment to upliftment is evident in his current philanthropic efforts. He currently supports 20 scholars, with 42 individuals having successfully
