BIMP Ensures PDL Safety Amidst Southwest Monsoon



The Bureau of Jail Management and Penology (BJMP) successfully evacuated Persons Deprived of Liberty (PDLs) from various jail facilities across the National Capital Region, CALABARZON, and Re-

gion 3 that were inundated by the continuous monsoon southwest downpour. BJMP Chief, Director Ruel "RSR" S. Rivera, reported no injuries or casualties among both PDLs and jail employees, with the

entire agency remaining on high alert. The seamless transfer of affected PDLs to temporary evacuation sites was a result of the combined efforts of the BJMP Special Tactics and Response (STAR) Team,
