





## BFP Holds Stakeholder Meeting on Fire



On August 12, 2025, top officials of the Bureau of Fire Protection (BFP), led by Deputy Chief for Administration Chief Superintendent Manuel M. Manuel (inset, top photo), met with various government agencies and professional organizations to discuss a proposed amendment to the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9514, also known as the Fire Code of the

Philippines. Spearheaded by the Directorate for Fire Safety Enforcement under Director Senior Superintendent Edwin P. Vargas, the meeting focused on amending a section of the RIRR to improve fire safety in wind energy facilities. The amendment proposes requiring Automatic Fixed Fire Suppression Systems (AFSS) in the nacelles of wind turbines, with the installation process to be based on a detailed

fire risk evaluation. The goal is to ensure that suppression systems can effectively cool and prevent fires in the nacelle's electrical and mechanical components while also allowing for maintenance access. The technical details of the amendment were presented by Eng'r. Ariel T. Miranda, Vice Chairman of the Technical Working Group (TWG), and TWG Chairman Senior Superintendent Juan Garry D. Lunas. On August 18, 2025, the Manila City Jail Male Dormitory (MCJ MD) celebrated the graduation of 311 persons deprived of liberty (PDL) who completed their basic education through the government's Alternative Learning System (ALS) program.






