



**EXECUTIVE ORDER No. 54** Series of 2025

AN ORDER ADOPTING THE IMPLEMENTING RULES AND REGULATIONS OF CITY ORDINANCE NO. 2013-047, CD NO. 11-2019, CO NO. 159-2021, CO NO. 2022-205, CO NO. 213-2022, CO 227-2022, CO NO. 308-2023, CO NO. 255-2023, CO NO. 322-2023, CO NO. 348-2024, CO NO. 405-2024 OTHERWISE KNOWN AS THE "REVISED TRAFFIC CODE OF THE CITY OF BACOOR"

WHEREAS, Section 16 of R.A. No. 7150 provides that every local government. unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare including the promotion of safety of its constituents and provision of adequate transportation facilities;

WHEREAS, the Sanggunlang Pantungsod enacted and passed City Ordinance No. 2013-047, CO NO. 11-2019, CO NO. 159-2021, CO NO. 2022-209, CO NO. 213-2022, CO 227-2022, CO NO. 308-2023, CO NO. 265-2023, CO NO. 322-2023, CO NO. 348-2024, CO NO. 405-2024, entitled "Revised Traffic Code of the City of Baccor";

WHEREAS, the City Government of Baccor recognizes the need to issue an Implementing Rules and Regulations pertinent to the above-mentioned Ordinance;

WHEREAS, the Office of the City Mayor of Baccor, in coordination with the concerned city government offices, issued the above-mentioned Implementing Rules and Regulations that shall govern City Ordinance (CO) NO. 2013-047, CO NO. 11-2019, CO NO. 158-2021, CO NO. 2022-209, CO NO. 213-2022, CO 227-2022, CO NO. 308-2023, CO NO. 255, CO NO. 322-2023, CO NO. 348-2024, CO NO. 405-2024;

NOW, THEREFORE, I, MICHAEL, E. SOLIS, Acting City Mayor of Baccor, Caville, by virtue of the powers vested in me by law, do hereby order for the adoption and implementation of the Implementing Rules and Regulations of Ravised Traffic Code of the City of Baccor.

Section 1. Implementing Rules and Regulations (IRR). Attached herein in the Implementing Rules and Regulations of City Ordinance (CO) NO, 2013-047, CO NO. 11-2019, CO NO. 159-2021, CO NO. 2022-209, CO NO. 213-2022, CO 227-2022, CO NO. 306-2023, CO NO. 255, CO NO. 322-2023, CO NO. 346-2024, CO NO. 405-2024, otherwise known as the "Revised Traffic Code of the City of Baccor", which shall form part of this Executive Order. This shall be known as the "The implementing Rules and Regulations of City Ordinance No. 2013-047, CO NO. 11-2019, CO NO. 159-2021, CO NO. 2022-209, CO NO. 213-2022, CO 227-2022, CO NO. 308-2023, CO NO. 255, CO NO. 322-2023, CO NO. 348-2024, CO NO. 405-2024, otherwise known as the Ravised Traffic Code of the City of Baccor". All affected offices and departments are hereby ordered to adopt the said implementing rules and regulations and be guided

accordingly. Strict compliance and observance of all city government officials and amployees to this IRR is hereby ordered.

Section 2. Repealing Clause. All previously issued orders and directives inconsistent with any provision found herein shall be deemed repealed, revoked, or amended accordingly.

Section 3. Separability Clause. In the event that any provision found herein shall be judicially or administratively declared illegal or infirm, the remaining provisions shall remain in full force and effect.

Section 4. Effectivity Clause. This Executive Order shall take effect immediately upon its signing and remain in full force and effect until repealed, revoked, or amended accordingly.

- Must be of legal age and have graduated from high school.
- A registered voter of the City of Baccor,
- 3. Has not been previously convicted of any crime;
- Possesses a valid driver's license and Willing to agree in writing to subject himselftherself to regular random drug
- and alcohol tests.

Traffic aides already employed who do not qualify with the foregoing qualifications shall be given one (1) year from the date of effectivity of the Revised Traffic Code to obtain the necessary qualifications.

#### **RULE V** POWERS, RESPONSIBILITIES, AND PROHIBITIONS

Section 15. Authority to Confiecate Licenses. - Traffic aides shall have the authority to confiscate the driver's license of drivers who violate any provision of the Revised Traffic Code or of any ordinance, law, or government regulation related to traffic management or road safety.

The deputized barangay officials/personnel shall likewise have the authority to confiscate the driver's license of a motorist. This authority may only be exercised within the barangay or specific location of his authority as indicated in the mission order issued to him/her by the BTMD head.

Section 16. Authority to Arrest, - While in the lawful exercise of their official functions, traffic aides and barangay officials/personnel shall be considered agents of persons in authority, and as such. They are hereby authorized to arrest any person who may have violated the Revised Traffic Code in any of the following instances:

- Disobedience to a lawful order endangering the public safety;
- Using his/her driven vehicle threatens the life of a traffic aide or barangay officials/personnel or the life of his/her family member
- Physically assault the traffic authorities while in the performance of their
- official duties; Transporting illegal goods or legal goods that are unlawfully obtained

A person who has been arrested under this provision shall be immediately turned over to the police authorities and shall be charged for criminal offenses penalized and defined under the Revised Penal Code, other pertinent laws, the Revised Traffic Code, or other ordinances of the City of Baccor.



WHEREAS, Section 43 (a) of Republic Act No. 6975 (also known as the "Department of the Interior and Local Government Act of 1990") as amended by Republic Act No. 8551 (the "Philippine National Police Reform and Reorganization Act of 1998") provides that "the sangguniang panlungsod/bayan in every city and municipality shall create such number of People's Law Enforcement Boards (PLEBs) as may be necessary: Provided, That there shall be at least one (1) PLEB for every five hundred (500) city or municipal police personnel and for each of the legislative districts in a city.

WHEREAS, Section 43 (b) of RA 6975 as amended provides that the PLEB shall have 'three (3) other members who are removable only for cause to be chosen by the local peace and order council from among the respected members of the community known for their probity and integrity, one (1) of whom must be a woman and another a member of the Bar, or, in the absence thereof, a college graduate, or the principal of the central elementary school in the locality."

WHEREAS, based on the 2020 census, the City of Bacoor has a population of 664, 625 spread more or less equally in its 47 barangays.

WHEREAS, Section 10 of Republic Act No. 10160 (the "Charter of the City of Bacoor") created two districts referred to as Bacoor West and Bacoor East for purposes of representation in the Sangguniana Panlungsod.

WHEREAS, the resolution of complaints filed by Bacooreños against police personnel assigned in the City of Bacoor is hindered by the fact that only one People's Law Enforcement Board (PLEB) of Bacoor presently exists in the city.

WHEREAS, there is a need to create two PLEB's for the City of Bacoor in order to speed up the process of exacting accountability from police personnel accused of violating their oaths of duty.

WHEREAS, it is imperative that measures be formulated by the Sangguniang Panlungsod that will ensure that the PLEB performs its functions properly and promptly to enhance the quality of service being rendered by police authorities and prevent abuses.

NOW THEREFORE, be it ordained by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite that:

Section 1. Creation of Two PLEBs. There shall be two People's Law Enforcement Boards (PLEBs) in the City of Bacoor, Cavite. One PLEB shall handle all complaints against police personnel that were filed by residents of barangays located within Bacoor West and another PLEB shall handle all complaints against police personnel that were filed by residents of barangays located within Bacoor East.

Section 2. Composition of PLEBs. The composition of the PLEBs created under this Ordinance shall mirror the provisions of Republic Act No. 6975 as amended as well as pertinent government regulations. Each PLEB under this Ordinance shall be comprised of:



Section 4. Removal from PLEB. The members of the PLEB appointed by the City Mayor may be removed for cause by the City

Section 5. Allowances. Members of the PLEB shall be given monthly allowances as may be allowed by law subject to availability

Section 6. Awards and Recognition. Police personnel who exhibited exemplary service over and above the call of duty, as recommended by the PLEB, shall be given cash rewards not less than Php 5,000.00 but not more than Php 20,000.00 as well as a Certificate of Recognition. The awarding of the said rewards shall be done together with the schedule handing of the Gen. Edilberto Evangelista Award and the Father Mariano Gomez Award.

Section 7. Live-streaming and Recording of Hearings. To promote transparency and ensure the regular performance of their official duties, members of the PLEBs are hereby required to record all hearings of the PLEBs. The said hearings shall, whenever the exigency of public service requires, also be live-streamed subject to the provisions of the implementing rules and regulations of this Ordinance.

Section 8. Implementing Rules and Regulations. The Office of the City Legal Service of the City of Bacoor shall submit the implementing rules and regulations of this Ordinance for the review and approval of the City Mayor not later than thirty (30) days from the date of effectivity hereof.

Section 9. Repeal. All ordinances, resolutions, executive orders and other local issuances inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

Section 10. Separability. In case a provision hereof is declared void by a court of law of competent jurisdiction, the remaining provisions of this Ordinance not affected thereby shall remain valid and enforceable.

Section 11. Effectivity. This Ordinance shall take effect immediately after it has been posted in at least three (3) inconspicuous public places within the City of Bacoor, Cavite.


