

scapes, pristine islands, and rich cultural heritage, Batanes truly lives up to its name as the Paradise of the North. The serene environment is one of the many reasons why, despite the expensive flights, tourists are still eager to experience the unparalleled beauty of Batanes.

The natives from Batanes, also known as the Ivatans, have long relied on farminggrowing vegetables and root crops for their family's consumption and selling excess to the local community.

Steep terrain naturally limits the agricultural activity in the province, yet despite this, some people have been dedicated to farming—among them are the couple Catalina and Ariston Laurel, who are both proud Ivatans and have been into farming for more than two decades. The couple has been residing in government-built housing in Diura, Batanes.

In addition to farming, her husband, Ariston, is also a fisherman, a job he learned from his father. Large bodies of water surround Batanes, making fishing one of the most common livelihoods there.

Ariston used to have a rowboat, but three years ago he was able to upgrade to a motorboat, which made fishing a lot faster.

One of the most sought-after fish in Batanes is the dorado, also known as the Ivatan Gold. It earned its name due to its high value, mainly because the drying process takes time,

and catching the dorado fish is a lengthy task.

They initially need to catch a shrimp to catch a flying fish. Once they have the flying fish, it serves as bait to catch dorado fish. Once properly dried, the dorado fish can be sold at a premium price of PHP 1,500.00 or more.

With the uncertainty of the weather, they constantly strive to maintain a steady income. Frequent storms often destroy their crops, forcing them to replant immediately. Aware that they cannot solely depend on agriculture, Ariston occasionally works as a construction worker.

To support their finances, in 2018, the couple became a CARD, Inc. (A Microfinance NGO) client. Shortly after they joined, her

husband unfortunately met with an accident, but thankfully was not seriously injured. They received financial assistance from CARD, Inc., which deepens their support for the institution, knowing they can rely on it in times of need.

Catalina used her current loan of PHP 20,000.00 to purchase seeds for farming and to pay for their children's school expenses. Meanwhile, Ariston used his loan of PHP 10.000.00 to buy parts for his motorboat.

Looking ahead, we aim to continue growing and expanding our crops and hopefully, in the years to come, we will be able to build a home that we can truly call our own," Catalina concluded.

#### **PROVINCIAL ORDINANCE NO. 486-2025**

AN ORDINANCE INSTITUTIONALIZING IN THE PROVINCE OF CAVITE THE PROGRAMS, SERVICES, PRIVILEGES AND BENEFITS FOR SOLO PARENTS AND THEIR CHILDREN, AND APPROPRIATING FUNDS FOR THAT PURPOSE

WHEREAS, Article II, Sections 9 and 10 of the 1987 Philippine Constitution provide that the State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living,

and an improved quality of life for all, and shall promote social justice in all phases of national development;

WHEREAS, provided in Section 2(a) of the Republic Act No. 11861, also known as the Expanded Solo Parent Welfare Act hereby declares that it is the policy of the State to support the natural and primary rights and duty of solo parents in rearing their children by providing for their basic needs, and extending to them assistance in social service and welfare benefits, with the end in view of uplifting their status and circumstances;

WHEREAS, Section 16, under General Welfare Clause of the Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, according to the data from the World Health Organization (WHO), there are approximately fifteen (15) million single parents in the Philippines, with over fourteen (14) million or 95% of it are women.

**WHEREAS**, the Provincial Government of Cavite aims to establish and organize the Solo Parent Sector in the province by giving them full support in implementing the programs, projects, benefits, and privileges given to them under existing laws and regulations;

**NOW, THEREFORE,** on motion of Hon. Enriquez, duly seconded by Hon. Sison and unanimously approved by the Members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

### ARTICLE I TITLE, POLICY, AND OBJECTIVES

**SECTION 1. SHORT TITLE:** This ordinance shall be known and cited as the "Expanded Solo Parent Welfare Ordinance of the Province of Cavite"

SECTION 2. DECLARATION OF POLICY. It is hereby declared the policy of the Provincial Government of Cavite to provide solo parents the opportunity to participate fully in the mainstream of society, giving them full support by implementing the programs, projects, benefits, and privileges given to them under existing laws and regulations, and improving their total well-being and valuing their dignity. Furthermore, it is hereby declared the policy of the Provincial Government of Cavite to encourage the formation and organization of the solo parent sector, and establishment of a database system for solo parents.

**SECTION 3. DEFINITION OF TERMS.** As used in this Ordinance, the following terms shall mean:

**A.Act** - refers to R.A. No. 11861 or the Expanded Solo Parents Welfare Act

**B.LGUs** - refer to Local Government Units;

**C.OPSWDO** - refers to the Office of the Provincial Social Welfare and Development Officer of the Province of Cavite;

**D.CSWDO/MSWDO** – refers to the City Social Welfare Development Office /Municipal Social Welfare Development Office of the City/Municipality of the Province of Cavite;



**E.Barangay Solo Parent Help Desk** – designed to provide support and services to solo parents within their communities. This program is in line with the Solo Parents Welfare Act (Republic Act No. 8972), which mandates the establishment of such help desks in every barangay to assist solo parents and their children.

**F.Solo Parent** - refers to unmarried, separated, annulled, widower, and widowed persons falling under the enumeration provided under Section 4 of the Act and its Implementing Rules and Regulations, who has taken the sole responsibility of parenthood.

**G.Spouse** - refers to a husband or wife by virtue of a valid marriage or a partner in a common-law relationship as defined in Article 147 of Executive Order No. 209, otherwise known as "The Family Code of the Philippines."

**H.Adolescent parents**-refer primarily to men and women who are nineteen (19) years of age and below, who have a child or children and opt to parent and raise the child or children on his/her own.

**I.Adoptive parent** - refers to a person who, through adoption, is considered the legitimate parent of a child, transferring all parental rights, responsibilities, and filiation to them. In order for an individual to become an adoptive parent, he/she must complete all the legal requirements and must have been decreed as qualified to adopt a child by the court, pursuant to Republic Act No. 11642 or the "Domestic Administrative Adoption and Alternative Child Care Act."

**J.Foster parent** - refers to a person who is duly licensed by the Department of Social Welfare and Development or the NACC to provide foster care to a child or children.

**K.Legal guardian** - refers to a person granted legal guardianship over the person or property, or both, of a minor or an incompetent, by a court of proper jurisdiction.

L.Relative within the fourth civil degree of consanguinity or affinity where "consanguinity" - refers to relationship by blood; "affinity" refers to relationship by marriage; 'relative within the fourth civil degree" includes one's spouse, parents, grandparents, great-grandparents, great-grandparents, great-grandparents, children, grandchildren, great grandchildren, great-great grandchildren, uncles, aunts, great-uncles, great-aunts, first cousins by virtue of a blood relationship or marriage.

**M.Cohabitation** - refers to a living arrangement whereby a couple who is not married, is living together in the same household. Couples in such a living arrangement may be of the same or different gender.

**N.Parental care and support** - refers to the acts of nurturing and providing for the basic needs, health care, mental and physical safety, emotional support, and development of the personality of the child, children, or dependent/s, and do not depend solely on the financial capability of or support given by the person obligated to support.

**O.Means-tested**- refers to the determination whether a solo parent has no visible means of income, or his/her income is otherwise insufficient to enable the solo parent to provide sole

parental care and support to a child, children, or dependent/s owing to the demands for subsistence of his/her family and the conditions prevailing in the place of residence.

**P.Persons with Disability (PWD) and those with special needs** - include those who have long term physical, mental, intellectual or sensory impairments which in interaction with various barriers may hinder their full and effective participation in society in equal basis with others.

**Q.Children or Dependents** – refer to those living with and dependent upon the solo parent for support who are unmarried, unemployed and twenty-two (22) years old or below, or those over twenty-two (22) years old but are unable to fully take care or protect themselves from abuse, neglect, cruelty, exploitation or discrimination because of a physical or mental disability or condition; Provided, that children or dependent/s entitled to be supported beyond the age of majority shall be limited to those who are in school or in training for some profession, trade or vocation, consistent with and as provided in Article 194 of Executive Order No 209 (E.O. No. 209), or The Family Code of the Philippines; Provided, further That this definition shall only apply for purposes of availing of the benefits under RA 11861;

**R.Child Minding Centers** - refer to a facility or area withintheworkplaceorinaccessiblelocations to the soloparent or workplace of the guardian provided by the employer where the children of a solo parent employee aged seven (7) years old and below are habitually received for purposes of care and supervision during working hours;

**S.Solo Parent Identification Card (SPIC)**- refers to the identification card issued to the solo parent as his/her competent proof of identification and the primary evidence of his/her status as a solo parent to enable him/her to avail of the benefits under this Ordinance and the Act;

**T.Flexible Work Schedule** - is the right granted to a solo parent/employee to vary his/her arrival and departure time without affecting the core work hours as defined by the employer;

**U.Parental Leave** - shall mean leave benefits granted to the solo parent to enable him/her to perform parental duties and responsibilities where physical presence is required;

**SECTION 4. SOLO PARENT CATEGORIES.** A solo parent refers to any individual who falls under any of the following categories, as provided by the Act:

A.A parent who provides sole parental care and support of the child or children due to:

1.Birth as a consequence of rape, even without final conviction: Provided, that the mother has the sole parental care and support of the child or children; Provided, further, that the solo parent under this category may still be considered a solo parent under any of the categories in this section;

2.Death of the spouse;

3.Detention of the spouse for at least three (3) months or service of sentence for a criminal conviction:

4. Physical or mental incapacity of the spouse as certified by a public or private medical practitioner;

5.Legal separation or de facto separation for at least six (6) months, and the solo parent is entrusted with the sole parental



care and support of the child or children;

6.Declaration of nullity or annulment of marriage, as decreed by a court recognized by law, or due to divorce, subject to existing laws, the solo parent is entrusted with the sole parental care and support of the child or children; or

7. Abandonment by the spouse for at least six (6) months;

B.Spouse or any family member of an Overseas Filipino Worker (OFW), or the guardian of the child or children of an OFW: Provided, that the said OFW belongs to the low/semi-skilled worker category and is away from the Philippines for an uninterrupted period of twelve (12) months: Provided, further, that the OFW, his or her spouse, family member, or guardian of the child or children of an OFW falls under the requirements of this section;

C.Unmarried mother or father who keeps and rears the child or children;

D.Any legal guardian, adoptive or foster parent who solely provides parental care and support to a child or children

E.Any relative within the fourth (4th) civil degree of consanguinity or affinity of the parent or legal guardian who assumes parental care and support of the child or children as a result of the death, abandonment, disappearance, or absence of the parents or solo parent for at least six (6) months:

Provided, that in cases of solo grandparents who are senior citizens but who have the sole parental care and support over their grandchildren who are unmarried, or unemployed and twenty-two (22) years old or below, or those twenty-two (22) years old or over but who are unable to fully take care or protect themselves from abuse, neglect, cruelty, exploitation, or discrimination because of a physical or mental disability or condition, they shall be entitled to the benefits of this Act in addition to the benefits granted to them by Republic Act No. 9257, otherwise known as the 'Expanded Senior Citizens Act of 2003;" or

F.A pregnant woman who provides sole parental care and support to the unborn child or children.

**SECTION 5. DUTIES AND RESPONSIBILITIES OF LGUS IN THE PROVINCE OF CAVITE.** To ensure the effective implementation of this Ordinance, the following LGUs shall perform the following duties and responsibilities:

A.The Province, through the OPSWDO:

1.Endeavour to ensure that the cities and municipalities within the Province of Cavite effectively respond to the mandate of the Act and maximize its efforts in reaching all its target beneficiaries; instruct and inform CSWDO/MSWDO and other concerned offices about the mandate of this Ordinance.

2. Supervise, monitor, evaluate, and consolidate by requiring the cities and municipalities within the Province of Cavite to submit quarterly a database concerning reportorial requirements of registered solo parents such as names, ages, addresses, income including the source thereof, name and number of children per solo parent and the circumstances of being a solo parent;

3. Give assistance to the cities and municipalities within the Province of Cavite by supporting the programs and

projects concerning solo parents and collaborating with the cities and municipalities for the efficient and effective implementation of the privileges and benefits to solo parents;

4.Other mechanisms and initiatives deemed necessary or vital for the full implementation of the provisions of this Ordinance.

B.The Cities and Municipalities, through the CSWDO/MSWDO:

1. The cities and municipalities within the Province of Cavite shall prioritize the implementation of the Act, allot necessary funds therefor, and continue to implement all existing programs and/or projects that benefit the solo parents.

2.Endeavour to ensure that the barangays within their respective jurisdictions effectively respond to the mandate of the Act and maximize its efforts in reaching all its target beneficiaries;

3.Create and maintain a database and database management system for the inventory of all individuals categorized as solo parents and conduct annual updating and re-assessment;

4.Produce, provide, and issue a Solo Parent Identification Card (SPIC) to qualified and registered solo parents;

5.Create a mechanism and method for identifying targeted solo parents or those that can be tagged as qualified to receive financial assistance;

6.Encourage and supervise the creation of solo parent federation in their locality; and

7.Other mechanisms and initiatives deemed necessary or vital for the full implementation of the provisions of this Ordinance

C.The Barangays, through the Punong Barangays and BSWDO and/or other concerned office:

1. Assist the cities and municipalities within the Province of Cavite in identifying and informing beneficiaries of the Act and this Ordinance as well as the implementation of its new provisions;

2.Undertake a barangay-wide registration of all the solo parents and their children for purposes of obtaining, among others, information on their names, ages, addresses, incomes including the sources thereof, number of children per solo parent, and the circumstances of being solo;

3.Update the list of all solo parents and their children at least every six (6) months;

4.Adopt and implement the mechanism and method created by the cities and municipalities within the Province of Cavite for identifying targeted solo parents or those that can be tagged as qualified to receive financial assistance; and;

5.Other mechanisms and initiatives deemed necessary or vital for the full implementation of the provisions of this Ordinance.

# ARTICLE II APPLICATION, QUALIFICATIONS, AND DOCUMENTARY



# REQUIREMENTS FOR SOLO PARENT IDENTIFICATION CARD (SPIC)

**SECTION 6. APPLICATION.** A solo parent shall file an application in his/her respective CSWDO/MSWDO, which shall undertake the registration of all solo parents and their children in their respective barangay for purposes of obtaining information on their names, ages, addresses, income including the source thereof, number of children per solo parent and the circumstances of being solo.

**SECTION 7. QUALIFICATIONS OF SOLO PARENT.** Before a solo parent obtains a Solo Parent Identification Card (SPIC) and avails the assistance, benefits, and privileges under this Ordinance and the Act, he/she must be qualified based on the following:

A.Applicant is in exclusive possession of parental authority, care, and financial maintenance responsibilities for a child or children, or dependents; Provided further, he/she does not engage in cohabitation and/or a co-parenting arrangement with another person, unless their spouse is incapacitated either physically or mentally, rendering them unable to fulfill the responsibilities of child care and support.

B.Applicant must be a resident of the Province of Cavite as certified by the Punong Barangay, or his/her duly authorized representative: Provided, that if he/she is a transferee from another barangay, he/she is required to secure a clearance from the previous barangay, indicating whether or not the applicant has availed of any benefits for solo parents, and the nature of such benefits; and

C.Applicant has no visible means of income, or his/her income is otherwise insufficient to provide sole parental care and support as set by the Philippine Statistics Authority (PSA) and assessed and means-tested by the CSWDO/MSWDO.

Provided, however, that any solo parent whose income is above the poverty threshold shall enjoy the benefits mentioned in Sections 11, 12, 13, 14, 15, 16, 17, and 18 of this Ordinance.

**SECTION 8. SOLO PARENT IDENTIFICATION DOCUMENTARY REQUIREMENTS.** Any solo parent who applies for a Solo Parent Identification Card (SPIC) must bring the following documentary requirements to the CSWDO/MSWDO:

A.Any government-issued ID to prove that he/she is a resident of the Province of Cavite;

B.Barangay Certification to prove that the applicant is a resident of the barangay;

C.PSA Birth Certificate of the child/children; and

D.Certification from the Barangay Captain indicating the status of the applicant as a solo parent or supporting documents such as Declaration of Nullity of Marriage, Certification of No Marriage (CENOMAR), Death Certificate of a spouse, Medical Certificate as proof of mental incapacity, if incapacitated, and other similar documents indicating the said status.

**SECTION 9. PROCEDURE AND ASSESSMENT OF CSWDO/ MSWDO.** Applicants are required to furnish the mandated set of documentary requirements when seeking to acquire a Solo Parent Identification Card through formal submission at the

CSWDO /MSWDO. This submission facilitates diligent verification and thorough assessment processes. They shall observe the following process:

A.Visit the CSWDO/MSWDO to manifest the need for assistance under this Ordinance and the Act;

B.Fill out Application Form for the assistance, supplying but not limited to, the following:

1.Name, age, and residence address;

2.Date and place of birth;

3.Information about employment, amount of and source/s of income, pension, or subsidy, when applicable. Provide proof of insufficiency of income such as payroll slip, barangay certificate of indigency or other documentation as may be determined by the CSWDO/MSWDO;

4.Information about children, including names of qualified children, ages, if in school, name of school and grade level, if with disability, Persons with Disability card or any proof of mental or physical disability that prevents the child/children from taking care of themselves; and

5. Circumstances of being a solo parent as indicated in Section 4 of this Ordinance.

Custodians of the documents, records, data, or information shall ensure that utmost confidentiality of the same, in compliance with Republic Act No. 10173, or the "Data Privacy Act of 2012";

C.Once required documentary requirements and duly filled Application Form is received, the social worker assigned by the CSWDO/MSWDO shall review and verify the documents submitted by the applicant within seven (7) working days from receipt of the complete documents, including in particular means-testing, namely the determination that the applicant's income is below the poverty line and is insufficient for subsistence in his or her place of residence;

D.Undergo the necessary eligibility assessment process conducted by the assigned social worker. The assigned social worker shall prepare the social case study report based on the information/data/documents provided for by the applicant, as well as on the social worker's assessment of said applicant, indicating therein the appropriate services needed.

The Social Case Study Report, together with a referral letter prepared by the social worker, shall be forwarded by the CSWDO/MSWDO to the concerned agency which provides the appropriate or required assistance/service.

SECTION 10. ISSUANCE OF SPIC AND BOOKLET. - The CSWDO/MSWDO shall provide, produce, and issue the Solo Parent Identification Card (SPIC) to qualified solo parents as stated in Sections 7 and 8 of this Ordinance. The Solo Parent Identification Card (SPIC) shall be considered as competent evidence of identity and membership in the sector as well as of the entitlement to the benefits and privileges under this Ordinance and the Act.

In cases of approval, the SPIC shall be issued within seven (7) working days from receipt of the complete documents. If the CSWDO/MSWDO will not be able to issue a physical SPIC to



qualified applicants, they must issue a Certification of Eligibility as a Solo Parent to the solo parent stating their status as a solo parent and reason for not being able to print a SPIC.

Prior to the issuance of the SPIC or Certificate of Eligibility, the CSWDO/MSWDO shall require the applicant solo parent to attend the Solo Parents Orientation Seminar to apprise him/her of the rights, duties, and obligations as a solo parent, including the benefits, assistance, and services available to him/her. The solo parent who has attended the seminar shall be given a Certificate of Attendance and a booklet.

The Certificate of Eligibility must be surrendered to the CSW-DO/MSWDO upon receipt of the physical SPIC.

In cases of dispute, the CSWDO/MSWDO shall resolve the same, which may include notifying the applicant to comply with the requirements within five (5) working days.

In cases of disapproval, the social worker must issue a written Notice of Disapproval to the applicant who was assessed not qualified to be a solo parent indicating the reason for such.

The SPIC and booklet shall be valid for one (1) year, subject to renewal conditioned upon the assessment and evaluation of the solo parent by the assigned social worker of the CSWDO/MSWDO.

### ARTICLE III BENEFITS, PRIVILEGES, AND ASSISTANCE

## SECTION 11. INCORPORATION OF COMPREHENSIVE PACKAGE OF SOCIAL DEVELOPMENT AND WELFARE SERVICES.

Not with standing with the mandate under the Act, the Provincial Government of Cavite and the cities and municipalities within the Province of Cavite shall encourage, continue, and enhance the implementation of existing programs, assistance and/or benefits and may develop expanded benefits to provide the solo parents and their children the welfare services and special privileges and benefits that the Act has enumerated, such as livelihood development services, counseling services, parent effectiveness services, and critical incidence stress debriefing and special projects for individuals in need of protection as mandated by the Act.

**SECTION 12. FLEXIBLE WORK SCHEDULE.** The Provincial Government of Cavite shall encourage employers within the Province of Cavite, whether public or private, to provide a flexible work schedule for solo parents: Provided, that the same shall not affect individual and company productivity.

**SECTION 13. WORK DISCRIMINATION.** No employer within the Province of Cavite, whether public or private, shall discriminate against any solo parent employee with respect to terms and conditions of employment on account of his or her status. All public and private establishments within the Province of Cavite shall create a safe and healthy work environment in coordination with the Department of Labor and Employment - Cavite.

**SECTION 14. PARENTAL LEAVE.** In addition to leave privileges under existing laws, all private and public institutions within the Province of Cavite shall grant to solo parents a forfeitable and noncumulative parental leave of not more than seven (7) working days with pay every year, regardless of employment status, who has rendered service of at least six (6) months.

The parental leave benefit may be availed of by the solo parent employees in the government and the private sector.

**SECTION 15. CONDITION FOR ENTITLEMENT OF PARENTAL LEAVE.** A solo parent shall be entitled to parental leave provided that:

a.He/she has rendered at least six (6) months of service whether continuous or broken;

b.He/she has notified his/her employer of the availment thereof within a reasonable period; and

c.He/she has presented a Solo Parent Identification Card (SPIC) to his/her employer.

**SECTION 16. CHILD MINDING CENTERS.** The Provincial Government of Cavite shall encourage and promote to the cities and municipalities, private institutions and establishments within the Province of Cavite the establishment of appropriate child-minding centers within the workplace, or in accessible locations to the workplace or residence of the solo parent.

**SECTION 17. BREASTFEEDING IN THE WORKPLACE.** In accordance with the Provincial Ordinance No. 212, also known as the "Lactation Station Ordinance of the Province of Cavite" and Republic Act No. 10028 otherwise known as the "Expanded Breastfeeding Promotion Act of 2009," the Provincial Government of Cavite shall continue shall strengthen and continue to encourage working mothers in the public and/or private sectors, who are solo parents, to practice breastfeeding in the workplace by setting up a lactation/breastfeeding area for this purpose.

**SECTION 18. SOCIAL SAFETY ASSISTANCE.** During disasters,

calamities, pandemics, and other public health crises as may be declared by the Department Of Health, the Provincial Government of Cavite, through the Office of the Provincial Disaster Risk Reduction and Management Officer (OPDRRMO), shall extend social safety assistance such as food, medicines, and financial aid for domicile repair to solo parents and their child/children who are residing within the province, subject to the guidelines of the Department of Social Welfare and Development. The Provincial Government of Cavite shall ensure that the budget for social safety assistance is included in the calamity funds of the province.

# ARTICLE IV ADDITIONAL BENEFITS, PRIVILEGES, AND ASSISTANCE TO SPIC HOLDERS

**SECTION 19. ADDITIONAL BENEFITS, PRIVILEGES, AND ASSISTANCE.** In addition to the welfare services, privileges, and benefits provided by the Act, solo parents who are a bona fide resident of the Province of Cavite and/or their children shall be entitled to the following privileges and benefits, to wit:

a.Monthly cash subsidy of One Thousand Pesos (P1,000.00) per month per solo parent who is earning a minimum wage and below, to be allocated by the concerned City/Municipality provided that the solo parent under this section is not a recipient of any other cash assistance or subsidy from any other government programs. A beneficiary who is a senior citizen or a person with disability (PWD) may continue receiving senior citizen or PWD benefits without forfeiting the benefits. City/Municipal Governments are encouraged to provide a monthly cash subsidy according to their capacity to fund and provide as such;



b.Ten per cent (10%) discount and exemption from the value-added tax (VAT) on baby's milk, food and micronutrient supplements, and sanitary diapers purchased, duly prescribed medicines, vaccines, and other medical supplements purchased from the birth of the child or children until six (6) years of age, where the solo parent is unemployed or is earning less than Two hundred fifty thousand pesos (P250,000.00) annually, subject to adjustment in accordance with the provisions on the exempt taxable income under the National Internal Revenue Code (NIRC), as amended by R. A. No. 10963 or "Tax Reform for Acceleration and Inclusion (TRAIN) Law";

c.Prioritization of solo parents, particularly solo mothers in re-entering the work force, and their children as applicable, apprenticeships, scholarships, livelihood training, reintegration programs of the government within the Province of Cavite;

d.Training Programs for Solo Parents and their Children at the Barangay level. Training programs for solo parents shall be provided in coordination with the barangay after the determination of the number of solo parents per barangay by the CSWDO/MSWDO. The type of training to be conducted shall be based on the training needs of the solo parents and their children;

e.Barangay Solo Parent Help Desk. The Barangay Kagawad in charge of the Committee on Women and Family Welfare shall spearhead the Barangay Solo Parent Help Desk and the database of solo parents in their respective barangay;

f.Prioritization and allocation in housing projects with liberal terms of payment on government low-cost housing projects in accordance with housing law provisions prioritizing solo parent who is below poverty line as assessed by the CSWDO/MSWDO and as declared by the Philippine Statistics Authority (PSA);

g.Death Benefit - The child/children of a registered solo parent at the time of the latter's death, if the cause of death is natural or by an accident is entitled to receive financial assistance of at least Two Thousand Pesos (Php 2,000.00), without prejudice to increasing the same at the mayor's discretion when the city/municipality budget so permits;

h.Scholarship Assistance - Children of solo parents are given priority in the granting of scholarship programs of the City/Municipality within the Province of Cavite;

are a priority for inclusion of the City's/Municipality's basic educational programs in the preschool, elementary, and secondary level, including the SPED (Special Education) Program;

j.Medical Assistance - A solo parent or his/her child shall be prioritized in all the medical assistance programs of the City/ Municipality within the Province of Cavite;

k.Livelihood Assistance - Solo parents shall have priority in the grant of livelihood assistance under any of the City's/ Municipality's applicable programs or projects, subject to the qualification requirements under existing ordinances, rules, and regulations;

I.Employment Assistance - Solo parents shall have priority

in the employment programs of the City/Municipality subject to job matching based on qualifications and experience; and

m.Other services, privileges, and benefits that the City/ Municipality is currently giving or may subsequently offer.

SECTION 20. PRESENTMENT OF SPIC AND AVAILMENT. Proof of membership and entitlement, as supported by the issued Solo Parent Identification Card, shall be presented by the solo parent and/or his/her children to avail of the above benefits granted under this Article.

#### **ARTICLE V** SPECIAL CITATIONS OF SOLO PARENTS

SECTION 21. ABUSED, ABANDONED, OR NEGLECTED SOLO PARENTS OR SOLO PARENTS WHO ARE VICTIMS OF **DOMESTIC VIOLENCE.** - In cases where a solo parent had been abused, abandoned, or neglected by his or her co-parent, he or she may seek the help of the CSWDO/MSWDO. The CSWDO/MSWDO shall coordinate with the respective barangay officials and/or police officers assigned in the nearest Philippine National Police station where the abused, abandoned, or neglected parent resides and in need of immediate and appropriate police assistance. The CSWDO/ MSWDO shall assist the abused, abandoned or neglected solo parent in securing legal, psychosocial, and other forms of assistance in the filing of cases of domestic violence or any legal action against the errant co-parent. Such assistance may include initiating discussion with and mediating between the parties, in cases of economic abuse, such as, but not limited to the errant co-parent's failure or refusal to support, or giving inadequate support, despite being gainfully employed and capable of giving support to the parent who has been abused, abandoned, or neglected by the co-parent and who is in need of support for herself and/or for her child and/or children with the co-parent, with the objective of coming to an agreement for the support of the spouse and their common child or children.

SECTION 22. SOLO PARENTS WITH DISABILITIES OR WITH **SPECIAL NEEDS.** Solo parents who have disabilities or special needs shall be given priority when it comes to granting and receiving welfare services, benefits, and privileges under Articles III and IV of this Ordinance.

SECTION 23. SOLO PARENTS WITH CHILD/CHILDREN/ DEPENDENTS WITH DISABILITIES OR WITH SPECIAL NEEDS. Solo parents whose children or dependents have disabilities or special needs shall be given priority when it comes to granting i.Basic Educational Services - Children of solo parents and receiving welfare services, benefits, and privileges under Articles III and IV of this Ordinance.

#### **ARTICLE V** LIMITATION AND TERMINATION OF THE BENEFITS OF A SOLO **PARENT**

**SECTION 24. LIMITATION.** Only qualified solo parent under Section 7 is entitled to claim the benefits of a solo parent under this Ordinance.

**SECTION 25. TERMINATION.** When a solo parent, as defined under Section 7 cease to be such by reason of a change of status and circumstances, the said solo parent shall be ineligible to avail of the benefits under this Ordinance.

SECTION 26. PROCEDURE FOR TERMINATION. In cases



where a solo parent has a change of status or circumstances making him/her ineligible to avail of the benefits of this Ordinance and the Act, the procedure for the termination of benefits of such solo parent shall be as follows:

1.A solo parent shall declare his/her intention to continue or terminate the provision of benefits and services before the lapse of one year from the issuance of the SPIC, the CSWDO/MSWDO which issued his/her SPIC which he/she shall surrender to the said C/MSWDO.

2.If the solo parent does not voluntarily declare his/her intention to continue or terminate the provision of benefits and services before the lapse of one year from the issuance of the SPIC, the assigned social worker, based on a report by the employer or any interested person, shall conduct the necessary assessment/evaluation to ascertain if grounds for termination and withdrawal of benefits exist.

3.The solo parent shall be informed of the result of the assessment/evaluation conducted by the Social Worker, including the termination of the benefits or services, if warranted, through a written notice, with proof of receipt of the solo parent. The termination shall take effect immediately upon the receipt of the notice of termination. The solo parent whose benefits have been terminated shall not use his/her SPIC after the receipt of the notice of termination.

4. The solo parent's failure to renew his/her SPIC on or before the end of the year of its issuance shall result in the automatic expiration of the SPIC after one (1) year of its issuance.

**SECTION 27. REINSTATEMENT OF BENEFITS.** The termination of said benefits be without prejudice to the reapplication of the solo parent and reinstatement of said benefits should the circumstances so warrant.

**SECTION 28. RELOCATION.** In the event a solo parent decides to relocate with his/her child/ren/dependent/s, he/ she shall inform the CSWDO/MSWDO which issued his/her SPIC and surrender his/her SPIC. The CSWDO/MSWDO of Cavite shall endorse and transmit the solo parent's records to the CSWDO/MSWDO of the place of relocation.

It shall be the duty of the CSWDO/MSWDO of the place of relocation who received said records, to assign a social worker to monitor the status of the relocated solo parent and his/her child, children and/or dependent/s. Moreover, it shall also be the duty of said officer to coordinate with the concerned agencies of any changes in the status of the solo parent receiving benefits from said agencies.

### ARTICLE VI CREATION OF SOLO PARENT OFFICE UNDER OPSWDO

**SECTION 29. SOLO PARENT OFFICE.** There shall be established a Solo Parent Office (SPO) under the Office of the Provincial Social Welfare and Development Officer. The Office of the Provincial Governor shall exercise supervision over the SPO relative to their plans, programs and activities.

The head of the SPO shall hold permanent position with at least a Salary Grade 12 and shall be appointed by the Provincial Governor. The SPO shall have at least three (3) staff members.

The SPO shall establish linkages and work together with accredited civil society and nongovernmental organizations, and political organizations.

The cities and municipalities within the province are encouraged to establish and create a Solo Parent Office (SPO) for cities or Solo Parent Division (SPD).

**SECTION 30. DUTIES OF SPO UNDER THE OPSWDO.** The Solo Parent Office shall have the following duties:

a. Maintain and regularly update the list of solo parents in the Province of Cavite;

b.Plan, implement, monitor, and evaluate yearly work programs in pursuance of the objectives of this Ordinance and the Act;

c.Serve as a general information and liaison center, providing information, education and communication (IEC) materials for solo parents for their use or for their children or dependents;

d.Monitor compliance with the provisions of this Ordinance and the Act, particularly the grant of privileges and additional benefit; and

e.Provide such other services as may be required under this Ordinance and the Act.

**SECTION 31. RIGHT TO ORGANIZE.** The Provincial Government of Cavite and cities and municipalities within the province shall encourage and give its full support to the solo parent's right to organize themselves for purposes beneficial to its members. The Solo Parents Organization/Federation shall assist the Provincial Government of Cavite and cities and municipalities within the province in the effective formulation and implementation of its program of services.

**SECTION 32. APPROPRIATIONS.** The amount necessary to carry out the provisions of this Ordinance shall be appropriated from the Gender and Development (GAD) funds of the LGUs subject to the proposed Annual Investment Plan anchored on the guidelines issued by the Department of Budget and Management (DBM), Department of Economy, Planning, and Development and Philippine Commission on Women (PCW).

**SECTION 33. SEPARABILITY CLAUSE.** If, for any reason, any portion or provision of this ordinance be declared unconstitutional or invalid, other provisions not affected thereof shall continue to be in force and effect.

**SECTION 34. REPEALING CLAUSE.** Any ordinance or issuances which are inconsistent herewith are hereby repealed, amended or modified accordingly.

**SECTION 35. EFFECTIVITY CLAUSE.** This ordinance shall take effect after its approval and compliance with the posting and publication requirements.




