JAIL CHIEF RIVERA SET TO RETIRE HIS BADGE

As the 16th Chief of the Bureau of Jail Management and Penology (BJMP), Director (a rank equivalent to a Major General in the Military) Ruel "RSR" S. Rivera, is set to conclude a remarkable thirty-year career. Vacating his position two weeks ahead of his compulsory retirement on January 5, 2026, his 56th birthday, Director Rivera leaves an indelible mark on the Bureau he diligently served, propelling it closer to its vision of becoming a highly capable agency dedicated to global best practices and standards in jail management. This forward momentum is encapsulated in the J.A.I.L. (Journey for Advancement, Innovation, and Long-Term Development) PLAN 2040, a comprehensive program aimed at transforming the

PGC Extends Vital Healthcare Services to GMA Resident



The Provincial Government of Cavite strengthened its commitment to community-focused healthcare through a medical and dental mission conducted on December 9, 2025, in Brgy. Poblacion 4, benefitting a total of 277 residents.

The initiative, spearheaded by the Office of the Provincial Governor – Medical Mission Team delivered an array of essential services aimed at addressing immediate medical concerns and promoting overall

well-being. Of the total beneficiaries, 227 residents received medical consultations, 50 underwent dental extractions, 13 availed of x-ray services, and 14 accessed ECG examinations, reflecting the wide-ranging support extended during the one-day activity.

5th District Board Member Aidel Paul Bellamide graced the mission, expressing full support for the province's continuing efforts to ensure that quality healthcare reaches every community, particularly those with limited access to routine medi-

cal services. The dedicated medical and dental team from General Emilio Aguinaldo Memorial Hospital (GEAMH) played a central role in the activity, offering their expertise and professional care to address the health needs of local residents. Their collaborative work with barangay health workers—who provided on-ground assistance and helped manage the flow of participants—ensured that the mission was orderly, accessible, and responsive to the community's needs.



nation's jail facilities and significantly improving inmate conditions through enhanced rehabilitation and reformation processes.

The J.A.I.L. PLAN 2040, meticulously crafted to align with the Jail Bureau's overarching goals and mandate, addresses several key areas: ensuring humane safekeeping and developmental opportunities for Persons Deprived of Liberty (PDLs), guaranteeing secure, clean, adequately equipped, and sanitary jails, implementing robust programs for PDL custody, security, and control, providing comprehensive welfare and development programs for PDLs, actively working towards jail decongestion, promoting good governance within the BJMP, and ultimately, aligning the BJMP with its vision of becoming a world-class agency by 2040.

Director Rivera's impactful tenure began on March 22, 2023, when he assumed the role of Officer-in-Charge Chief. His dedication and vision were formally recognized on June 26, 2026, with his appointment as full-fledged Chief by President Ferdinand R. Marcos, Jr. Under his leadership, Director Rivera steered the BJMP to achieve numerous tangible accomplishments, many of which set new precedents in the Bureau's 34-year history.

Tangible Achievements

One of the most notable achievements has been the relentless effort to address jail congestion. The national overcrowding rate saw a significant drop from 358 percent in 2023 to 286 percent in 2025. This positive transforma-

tion was largely driven by the release of approximately 85,183 PDLs over the past year. This massive decrease is a testament to strengthened paralegal assistance, the addition of new jail facilities, and robust partnerships forged with key stakeholders such as the Supreme Court, the Public Attorney's Office (PAO), the Integrated Bar of the Philippines (IBP), and various law schools nationwide.

In solidifying his leadership's legacy, the Bureau has overseen the construction of nine new jail buildings, six perimeter fences, and one functional area, with an additional 19 perimeter fences and 15 functional areas actively under development. These infrastructure improvements are vital to providing a more conducive environment for both PDLs and personnel.

A hallmark of Director Rivera's strict policy adherence was the all-out drive to eradicate illegal drug activities within jails. This critical feat was accomplished with the crucial support of partner agencies like the Philippine National Police and the Philippine Drug Enforcement Agency. This sustained effort culminated in 230 jails being recognized and awarded with drug-free certifications, and 77 facilities being declared drug-cleared, a direct result of the remarkable 314,819 greyhound operations conducted nationwide. The vigilance, discipline, and dedication of jail personnel were further exhorted, leading to the successful prevention of contraband smuggling, with the confiscation of approximately 500 grams of shabu, 33 grams of marijuana, and 83 mobile phones.

Playing a pivotal role in transforming the lives of PDLs, the Katatagan, Kalusugan at Damayan sa Komunidad (KKDK) program achieved significant milestones. Notably, 3,152 PDLs with substance use issues successfully completed reformation programs. Additionally, 66,354 PDLs engaged in various livelihood activities, collectively generating over P116 million in income. The program also extended its reach to 95,585 PDLs, who benefited from e-Dalaw or electronic visitation, enhancing their crucial connection with loved ones.

Reinforcing its commitment to education, the Bureau's programs have enabled substantial progress for PDLs. So far, 10,739 PDLs have successfully completed elementary and high school via the Alternative Learning System (ALS), and 112,707 have acquired valuable skills through various training initiatives. Further demonstrating this dedication, 107 PDLs have earned college degrees through the "College Education Behind Bars" program, with an additional 720 currently enrolled in tertiary studies. Upholding PDLs' constitutional rights, particularly the right to suffrage, a total of 31,689 PDLs successfully participated in the May 2025 National and Local Elections by casting their votes.

On the aspect of special treatment for high-profile PDLs, the Bureau firmly maintained its policy

that all PDLs are treated equally, without special privileges, subject to the same rules, regulations, and standards of care as other inmates within the detention facility.

Strengthening Personnel and Future Outlook

Personnel development remained a top priority for the Bureau under Director Rivera, evident in the 1,499 promotions processed and over 27,000 awards and commendations conferred. The Rivera-led BJMP continues to achieve success through its modernized management and operational public service, steadfastly guided by its J.A.I.L. Plan 2040, steadily advancing towards world-class agency status. This unwavering commitment has earned the Bureau praise for its PDL Assessment and Classification System for terrorism-related and violent extremist offenders.

To further boost operational capacity and ensure safer jail environments, 2,400 new Jail Officer 1 (JO1) recruits recently took their oath of office. This influx of personnel has significantly improved the PDL-to-officer ratio from 1:42 to 1:36 so far. This increase, combined with other security measures, has contributed to a 10-percent reduction in jail incidents.

The impending retirement of Chief BJMP, Director Rivera, signals not an end, but another milestone in the making. His successor will undoubtedly continue not only his profound legacy but also the collective legacies left behind by the distinguished Chiefs who have served the Jail Bureau.



KERNELS OF HOPE



Chella Baraquel operates a food cart that offers freshly boiled corn, peanuts, and buttered corn kernels, each product telling the story of her hard work and homegrown success.

Like the kernels of corn that endure heat, pressure, and time, yet remain full of potential to grow tall and strong, Chella Baraquel, a corn vendor from San Vicente North, Calapan City, Oriental Mindoro, embodies survival and resilience in both life and business. From a simple kariton they built themselves to a permanent stall in the market, Chella and her family turned their humble beginnings into a lasting space to sell corn.

At an early age, Chella learned the values of perseverance and self-reliance. She had to leave school early due to family circumstances, having only reached the third year of high school, which prompted her to start working and support herself. She left home at the age of 16 and worked various jobs: a household helper in Manila, a contractual factory worker in Laguna, and then a cashier and waitress in Batangas. Each role refined her work ethic and determination to persevere.

When she returned to Oriental Mindoro in 2007, fate introduced her to Jeffrey Casalla, the man who later became her partner. Together, they faced the daily challenges of making ends meet. With little to no

capital, they started selling root crops and fruits, such as singkamas and rambutan, using a kariton they had built themselves.

By 2009, they turned to selling corn, which soon became their steady source of income. Without a fixed supplier, they learned to adapt, constantly finding ways to keep their business running. Their persistence enabled them to meet customer demand and support their growing family.

But in 2014, everything changed. A series of financial challenges struck their family, draining their business capital and even their daily funds for food and expenses. With no resources left to sustain the business, Chella made the painful decision to seek work abroad in Egypt as a domestic helper. Unfortunately, even there she faced hardships. Chella experienced maltreatment and abuse by her employers and was forced to return home after several months.

That same year, her partner, Jeffrey, became a client of CARD Bank, a microfinance-oriented rural bank, and applied for a PHP 5,000 loan to revive their corn business while Chella was abroad. In 2015, when Chella decided to stay home for good, she also became a member of

were forced to sell their tricycle just to survive. Before this happened, they had taken out a loan of almost PHP 80,000 from CARD Bank to expand their business further. That very loan became their lifeline, helping them keep their business afloat by selling within nearby neighborhoods and covering their daily expenses. After the pandemic, they gradually repaid the loan little by little while rebuilding their business.

With only limited resources left, they began again with just two sacks of corn as their supply, steadily earning and saving until their livelihood regained its strength. They expanded their product offerings to include peanuts, boiled corn, and buttered corn. They were even able to purchase a new tricycle, gradually recovering what they had lost during the pandemic.

Chella believes that true capital in life and business is not just money, but also patience, hard work, and perseverance. Like a kernel of corn that grows into a strong, sustainable livelihood, her story reflects steady effort overcoming challenges.

In the future, she and her partner, Jeffrey, hope to have their own non-rented stall and expand into fruits and condiment retail, a dream they will once again pursue step by step, believing that setbacks are never final for those who keep moving forward.
