

The assessment brings together key stakeholders, including Mayor Strike B. Revilla, Councilor Horacio Brillantes, Atty. Aimee T. Neri (City Administrator & Head of HUDRD), Dr. Abraham De Castro (Head of PESO), and Ms. Memviluz L. Baurile (CIGOO Head of DILG Bacoor). The LRTA family

is represented by LRTA Administrator Atty. Hernando Cabrera and Engr. Joseph Dexter Buenconsejo, LRTA Project Manager. Officers and representatives from DOTR, DHSUD, NHA, PCUP, and the City Government of General Trias are also participating.

During the assessment, Mayor Strike B. Revilla emphasized the City Government's commitment to supporting relocated families. "The City Government, through HUDRD, is providing assistance beyond financial aid and relief packs. We are offering livelihood profiling to address their job needs, helping children transfer schools, and expediting electricity connections

with the help of Meralco. We have also reached out to the Department of Agriculture to bring KADIWA stores to relocation sites, providing affordable rice and vegetables. We know the Government of General Trias will not abandon our constituents."

Mayor Strike added, "While there is no place like home, home is where the heart is. Even though some of our fellow Bacooreños may be far away, the City Government of Bacoor remains open to assisting them in any way we can. Our dream for every Bacooreño family is a peaceful and progressive future, and we can only achieve this through mutual support and compassion."

# **PGC** conducts Medical and Dental Mission in Sta. Cruz 2, City of Dasmariñas




he Provincial Government of Cavite





# CAVITE PNP WARNS PUBLIC **AGAINST ILLEGAL SELLING OF** MERALCO ELECTRIC METERS

a m p BGen Pantaleon Garcia, Imus City,

Cavite — The Cavite Police Provincial Office under the leadership of PCOL ARIEL R RED, Acting Provincial Director, issued a stern warning to the public against the illegal selling and purchasing of Meralco electric meters, emphasizing that such activity constitutes a violation of Republic Act No. 7832, otherwise known as the Anti-Electricity and Electric Transmission Lines/Materials Pilferage Act of 1994.

PCOL Red reminded the public that only Meralco-authorized offices and accredited dealers are permitted to sell, install, or replace electric meters. Unauthorized possession, sale, or use of these meters may lead to criminal charges, as stated under Section 6 of R.A. 7832, which imposes the penalty of imprisonment of six (6) years and one (1) day to twelve (12) years, or a fine ranging from Ten thousand pesos (₱10,000.00) to Twenty thousand pesos (₱20,000.00), or both, including the confiscation of all electric materials, devices, or meters involved in the violation. He further warned that those proven guilty of tampering or selling unauthorized electric meters may also face disconnection of electrical service and permanent disqualification



from future power service connections.

PCOL Red urged residents to remain vigilant and report any person or establishment involved in the illegal trade, tampering, or installation of electric meters to the nearest police station or through the official Cavite Police Provincial Office Facebook page.

# A New Beginning Behind the Storefront





What began as a small sari-sari store in 2020 has become a growing livelihood for Ainon Saddaramil, driven by her tireless efforts.

he Tausug are one of the Muslim tribes

residing on the island of Mindanao. Many of them originally came from Jolo, but over the years, some have moved and made a new life in places like Zamboanga City. One of them is Ainon Jabani Saddaramil, whose story is a testament to the hard work and resilience that comes from building a better

life for her family.

A turning point in her journey

Ainon lost her father at a young age. As the eldest of five siblings, she began working at the age of 10 to help support her family alongside her mother. She would accompany her in the rice fields, plowing the land and harvesting rice grain. She continued this kind of work throughout her youth until she decided to seek an opportunity

abroad as a domestic helper.

She worked abroad for two years before returning home. Ainon intended to go overseas again, but her plans were halted when she fell ill. Although it was disheartening, she had no choice but to move on and continue her life in the Philippines.

Using the money she saved from working abroad, she started a small barter trade business selling Muslim dresses. It was through this business that she met her husband. After they got married, they bought a jeepney, which her husband used for a living, while she worked at a nearby eatery, but had to stop after being pregnant with her youngest child.

To continue earning, she started cooking and selling traditional Muslim snacks. Around the same time, she also turned the second floor of their house into a boarding house to earn an extra income.

Currently, she rents out six rooms in her home. As she got older, she also stopped selling snacks because the heat of cooking became too hard for her to bear; instead, she opened a small sari-sari store at home using the PHP5,000.00, which she saved from her boarding house income.

To have additional capital for her business, she became a client of CARD, Inc. (A Microfinance NGO) in 2020. A friend who was

already a client encouraged her to join and give it a try. Through the Musharakah contract financing she received from the institution, she was able to expand the range of products she offered in her store.

Musharakah contract financing is a Shari-ah inspired counterpart of a regular loan, designed to help clients with existing businesses or those looking to start a new venture. Served as an additional capital, this financing is disbursed in cash to support business growth. In a Musharakah contract, both financier and the business owner contribute capital to business venture, and profits are shared based on agreed-upon ratio.

"Back then, my store had very limited items, but I used the Musharakah contract I received from CARD, Inc. to buy more products and expand my display," she stated.

She now has an active Musharakah contract of PHP 30,000.00, which she uses for her

business.

One of the things she appreciates about running a sari-sari store is that it is not physically demanding. The business allows her to spend more time and be more present for her children, especially when they are not in school.

"It is truly my dream for my children to finish their education. My husband and I work hard to make that happen because I experienced firsthand what it feels like not to finish school, and I do not want my children to go through the same struggles I face," she said.

To date, three of her children have already graduated, while the other three are still in school. This achievement is the result of the unwavering hard work determination and she and her husband have poured into their family. Looking ahead, she hopes to see all of her children complete their education and to further grow their sari-sari store, which continues to be their main source of income.

Back then, she and her husband were just trying to make ends meet. They sold mangoes, a business that is typical of their hometown, hoping to bring in enough to provide for their family. But dreaming of something bigger, life led them to venture in another line of business.

# From fruit to foundation

Seeking better opportunities, they ventured into ironworks and aluminum glass. As competitors emerged, they shifted to selling construction materials. Gradually, they gained the trust of their community as a primary supplier of roofing sheets and other building essentials.

tablishing its roofing sheet manufacturing facility. Being the only supplier in their area with a roll-forming machine, they offer high-quality products at lower prices. They supply materials such as steel, wood, paint, cement, hollow blocks, and roofing sheets to resorts, road-widening projects, and other construction sites.

As the business grew, Florabelle became a client of CARD SME Bank, Inc., a thrift bank under CARD MRI, opening new doors for their business. She started with an initial loan of PHP 300,000, which later grew to PHP 2,000,000, allowing them to invest in modern machinery and expand operations.

"Aside from our dedication and unified efforts, CARD SME Bank has played a crucial role in our growth. Through its financial assistance, they enabled us to invest in advanced machinery and

improve our services," Florabelle said.

Looking back, Florabelle sees how their lives have changed. Their business has expanded, they have acquired essential equipment, and built their dream home. For her, success is rooted in faith, trust, and treating employees as family.

"Through dedication and resilience, I hope our story proves that dreams are not just imagined; that they are built through hard work and unwavering faith in God," she concluded.

h e long-anticipated interoper-

ability of expressways operated by SMC Infrastructure and Metro Pacific Tollways Corp. throughout Luzon is now complete, with both firms officially launching the One RFID program Tuesday in Calamba, in ceremonies attended by President Ferdinand "Bongbong" Marcos, Jr.

"We are proud to announce the successful completion of interoperability between our electronic toll collection (ETC) systems, Autosweep and Easytrip. This latest feature will directly benefit motorists who will register for a new ETC account, as they will only need one radio frequency identification (RFID) and account to travel seamlessly across the Luzon expressway network," both companies said in a joint statement.

The One RFID program covers all toll roads in Luzon such as Tarlac-Pangasinan-La Union Expressway (TPLEX), Subic-Clark-Tarlac Expressway (SC-

TEX), North Luzon Expressway (NLEX), NLEX Connector, Skyway System, NAIA Expressway, Manila-Cavite Expressway (Cavitex-C5 Link, Muntinlupa-Cavite Expressway (MCX), Cavite-Laguna Expressway (CALAX), South Luzon Expressway (SLEX), and the STAR Tollway.

Registering for the One RFID program is optional. Motorists with existing, separate Autosweep and Easytrip RFIDs and accounts may choose to join the toll interoperability program, but those who

choose to maintain two separate RFID accounts, may also do so, the companies said.

This project was initiated by government through the Department of Transportation (DOTr) and the Toll Regulatory Board (TRB), in line with their mandate to improve the efficiency of the country's expressway network.

The private operators had been working closely with government over the years, to make the vision of toll interoperability a reality

"The road to One RFID was not easy, as it required extensive work on the part of all stakeholders. Both ETC providers made significant upgrades to their existing infrastructure to integrate their systems, while conducting rigorous testing to ensure smooth and seamless interoperability," the firms said.

With the completion of the interoperability project, the expressway operators said their focus will now be on roll-out—making registration to the One RFID program more convenient and accessible—as well as continuous improvements to the system, to ensure overall better experience at the expressways for motorists.
